Course Overview and Objectives

ANS 6711 utilizes a hybrid approach involving online recorded videos, in-person lectures, and reading assignments to provide students a detailed overview of essential macro- and micro-elements in livestock nutrition. Although all livestock species will be included, the course will provide a special focus toward forage-consuming livestock. Topics will include the role, function and metabolism of essential minerals. Requirements, sources, deficiency, and toxicity symptoms will be covered. Students will learn practical formulation calculations and supplementation strategies. The course is enhanced by the inclusion of recorded expert interviews.

Learning Objectives

1. Understand the role, function, and metabolism of essential minerals in livestock nutrition
2. Recognize symptoms of mineral deficiency and toxicity
3. Formulate mineral premixes and apply practical supplementation strategies

Prerequisites

A course in animal or human nutrition is required. This prerequisite may be waived with sufficient evidence of appropriate previous coursework and experience.

Course Assignments and Exams

Final grades are based on a semester total of 100 points derived from the sum of 3 written exams (25 points each) and 6 unscheduled quizzes (5 points each). Exams will test your knowledge of all course material from the start of the course up to the exam. Therefore, Exam 3 will essentially cover all material in the course. There will be no final examination.

Exams are prescheduled. If you have an extreme-case conflict, please notify the instructor as soon as possible so alternative arrangements can be made. Class attendance is an expectation. There will be no make-up opportunity for quizzes that are missed due to attendance. The lowest quiz grade will be dropped from the calculation of the final grade.
